Frequently Asked Questions: Federal Good Time Credit

Good time credit is earned for "good behavior" described in law as "exemplary compliance with institutional disciplinary regulations" Good time credit reduces a prisoner's actual time in Bureau of Prisons (BOP) custody This time off is also called "good conduct time" The law governing good time can be found at 18 USC § 3624(b)
